In pursuance of Para 12 of Biotechnology Policy Resolution 2016, No.5444/ST dated 24/11/2016, Government have been pleased to constitute a Project Facilitation Unit (PFU) which will act as the Secretariat for assisting the Single Window Clearance Committee and coordinate with the State Level Facilitation Cell (SLFC) and District Level Facilitation Cell (DLFC) notified by the Industries Department vide its Notification No.4086 dated 23rd June, 2015. The PFU shall function under the overall supervision of Commissioner-cum-Secretary to Government, Science & Technology Department.

Project Facilitation Unit (PFU): The PFU shall function at Science & Technology Department level and shall consist of the following members;

- i) The PFU may co-opt members from other Departments/Organizations and/or Experts as and when required.
- ii) The functions of the PFU shall be as follows:
- a) Prepare operational guidelines on implementation of provisions of Biotechnology Policy Resolution 2016 (BPR 2016)
- b) Guide and mentor investors

- c) Follow up on project proposals received at Department level, SLFC & DLFC
 - d) It may engage experts/ specialized unit on out sourcing basis as per requirement.
 - e) Any other function as directed by the Chairman.
- iii) The PFU shall meet on monthly basis on a fixed day or whenever necessary as decided by the Chairman.

This Notification shall come into force with immediate effect.




