 - a) The SLIC will review the effective allocation of funds available in the State for Biotechnology ventures and Biotechnology infrastructure development.
 - b) It will identify key biotechnology areas for investments in research and technology development as is necessary for the State.
- c) It will promote research in the emerging and nascent technologies by inviting proposals from different institutions and industries and providing financial assistance.
- d) The SLIC will help the State in creating greater public awareness issues arising which impinge on aspects of culture, morality, ethics, economics etc.
- The Chairman of the Committee shall preside over the meeting. iv) v)
- The Committee will meet at least once in six months or whenever necessary to discuss any issue on the aims and objectives of the committee as envisaged above.

This Notification shall come into force with immediate effect.
