In the event of joint award the prize amount will be equally divided between the awardees " will be deleted and in its place the following sentence will be inserted:-

"The expert panel shall recommend for single award only".

(2) A new column namely column-16 shall be added after the column-15 of the proforma appended to the said Resolution which is as follows:-

"16. whether any adverse report is pending against the nominee in public life ?"


