In pursuance of the provisions contained in Para-(vii) of the Memorandum of Orissa Bigyan Academy, Government of Orissa has been pleased to make the following amendments to the "Guideline and Nomination Proforma for Orissa Young Scientists Awards" for Science & Technology issued in Science & Technology Department Resolution No.1110, dated 18.02.2009.

AMENDMENTS

(1) At Para-5 of clause-8 of the said Resolution, the existing sentences such as "Each panel should ordinarily recommend one name in each of the branches, as defined in Clause-2 for the award for the year. In the event of joint award the prize amount will be equally divided between the awardees" will be deleted and in its place the following sentence will be inserted.

"Each panel should recommend one name only in each of the branches as defined in clause-2 for the award for the year "

(2) A new column namely column-12 shall be added below the column-11 of the Proforma for Nomination annexed to the said Resolution which is as follows:-

"12. Whether any adverse report is pending against the nominee in public life?" Yes/ No.

If yes, please mention the details. (Please attach additional sheets if required).


