  - ii) The PAVG may consider special invitees from Industries/Industry Bodies or Subject Matter Experts from Institutes/Industry on issues of special interest.
  - iii) The aims & objectives of the PAVG are as follows:
    - a) It shall also recommend policy advice to the Government on various programs and initiatives that are relevant to expand and strengthen the Biotechnology sector.
    - b) The PAVG would facilitate proper and timely implementation of this policy, and will ensure social and economic benefits of biotechnology are made available widely.
    - c) The PAVG will develop, in phases, systems & mechanisms to bring a paradigm shift in the approach of biotechnology education & research, commercialization of products & services, investment, collaboration, skill development through wide range of programs and tasks.
    - d) The PAVG will also be responsible for reassessment of priority areas for growth, constitution of Special Task Forces from time to time.
  - iv) The Chairman of the PAVG shall preside over the meeting.
  - v) The tenure of the PAVG is two (02) years.
  - vi) The PAVG will meet at least once a year or whenever necessary to discuss any issue on its aims and objectives as envisaged above.

This Notification shall come into force with immediate effect.
