

## Advertisement

Applications are invited for filling up of the following positions in the Institute of Entrepreneurship Development (IED), Odisha, a society under Department of Micro, Small & Medium Enterprise, Government of Odisha .

A. It is proposed to fill up the post of Chief Executive (Director) of Institute of Entrepreneurship Development (IED), Odisha in the pay scale of Rs. 37,400-67,000 + 8,700 Grade pay on deputation /short term contract basis from the Officers of State/Central Government/Bank and reputed Entrepreneurship Development Institutions fulfilling the following Criteria:

- Holding analogous post on regular basis in the parent cadre/department or
- With five years of service in the grade rendered after appointment thereto on a regular basis in the scale of pay of Rs. 37,400-67,00+7600 Grade pay
- Officers with 5 years of service in PB-3 with Grade Pay Rs. 6600 would also be considered and in that case he will be placed in the scale of pay of Rs. 37,400-67,000+7600 Grade pay
- Possessing degree in Engineering /Post Graduate in Arts/Science/Commerce /MBA etc. with at least 5 years of experience in Entrepreneurship Development /Promotion of Micro and Small Enterprises etc., Development of Literature/Research in the field Entrepreneurship Development
- The maximum age limit for appointment by deputation including short term contract shall not exceed 57 years as on the closing date of the receipt of the application.
- Officers from Government of India / Officers from reputed organization such as Entrepreneurship Development Institute (EDI), Ahmedabad or National Institute for Micro, Small and Medium Enterprises (NIMSME), Hyderabad or The National Institute for Entrepreneurship and Small Business Development (NIESBUD), Noida or Indian Institute of Entrepreneurship (IIE), Guwahati, who have left the organization but less than 57 years of age will be considered.
- The professionals from reputed institutions and Government of India Officers/Nationalized Banks will be allowed to work till the age of 60 years.

B. It is also proposed to recruit 3 officers on contractual basis with a monthly consolidated pay of Rs. 9,300/- in the area of Food Processing, Project Preparation & Appraisal and Entrepreneurship Development & Training.

The applicants should be an MBA from a reputed organization with having experience in the relevant fields. The Minimum age should not be less than 21 years and maximum age limit is 35 years.
