TERMS AND CONDITIONS

The following terms and conditions must be fulfilled by the successful bidder for Auction sale of the vehicle.

- The offset price of the vehicle has been fixed at Rs. 1,80,000/- (Rupees One lakh eighty thousand only).
- 2. The intending bidders may inspect the vehicle at Premises of Kharavela Bhavan, Unit-V, Bhubaneswar on any working days during the office hour well in advance.
- 3. Submission of Sealed tenders will be taken as sufficient proof of the tenderer to have inspected the vehicle put for auction sale and no further complaint regarding the condition of the vehicle will be entertained on any circumstances. The auction sales of the vehicles are done as is where is basis.
- 4. The intending tenderer will have to submit an earnest money deposit of Rs.1000/- (One thousand) only in shape of bank draft in favour of the Under Secretary to Government, Science & Technology Department, Bhubaneswar along with the sealed tender which shall be subject to refund immediately except in case of the highest offer accepted by the competent authority. Tender papers without EMD in shape of bank draft will be rejected.
- 5. The tender papers received will be opened in the presence of the tenderers or their authorised agents before the Committee on 29.06.2022 at 04.00 P.M. If the date of opening of tenders is declared as a Govt. Holiday, the tenders will be opened in the next working day as per the schedule time. The tender cover should he super scribed as "TENDER FOR AUCTION SALE OF VEHICLE".
- 6. Tender with highest offer of BID amount shall be accepted and such tenderer shall have to deposit 25% of the accepted highest tender amount including the EMD amount immediately after the announcement and the rest 75% within 7 days from the date of issue of ratification order or confirmation of the tender. However, the committee reserve the right to allow more time to the highest bidder for payment of 75% of the accepted highest tender amount for the interest of the state. The highest tender below the upset price will be referred to the competent authority for decision.

- 7. In case the highest tenderer fails to deposit the tender amount within the stipulated period from the date of ratification order/confirmation of tender, 25% of the tender amount including EMD amount deposited on the date of opening of the tender will be forfeited to Government and the vehicle will be put to resale entirely at the risk of the highest tenderer.
- 8. The vehicles shall not be delivered to the highest tenderers till full payment is made and other formalities are fulfilled.
- 9. The highest tenderer shall take delivery and remove the vehicle from the Premises of Kharavela Bhavan, Unit-V, Bhubaneswar within 7 days from the date of ratification order/confirmation of tenderer on full payment of the highest tendered amount failing which no claim will be entertained on any circumstances later on and the custody and safety of the vehicle shall be the responsibility of the tenderer.
- **10.** The tools, RC books or other documents of the vehicle shall not be supplied to the highest tenderer with the vehicle.
- **11.** The transfer of ownership of the vehicle will be made on deposit of requisite fee and submission of proper application form and other required documents by the highest bidder.
- **12.** No one except intending tenders or the authorised representative of the tenderers shall be allowed at the time of opening of seal tender.
- 13. Tender Application form shall not be accepted after 5 PM on 28.06.2022.
- **14.** In case of any complain/objection or claim relating to the auction sale is raised, then the decision of the committee shall be conclusive.
- **15.** Any dispute/litigation on the auction sale shall be subject to the jurisdiction of Bhubaneswar only. The committee reserves the right to accept or reject any or all the tenders without assigning any reason thereof.
