2. Tenure of the post - 2 years from the date of joining.
3. Salary, Qualification, Age & Experience

1	Salary	Rs. 37,400 - 67,000 + AGP- 9000 or Rs. 15,600 - Rs. 39,100 + AGP - 6,000 Depending upon the availability of candidates.
2	Qualification	P.G in any stream of Basic Sciences or Graduate in any branch of Engineering/ Technology (Ph.D/ higher qualification is preferred)
3	Age	Not more than 65 years
3	Experience	Minimum 5 years experiences in the rank of Reader or equivalent post of Central/ State Government or Minimum 3-year experiences in Scientist D of the Research Institutes in Govt. of India.
